To help assure the safety of children the YMCA follows a comprehensive hiring protocol for volunteer and paid staff, including thorough interviews and reference checks, criminal background screening through the California Department of Justice and Federal Bureau of Investigation, and review and acceptance of the YMCA Code of Conduct.
